New Databases

- **PsycARTICLES** – Search the full-text of almost 80 key peer-reviewed journals from APA, covering the behavioral sciences and related fields ranging from education, to nursing, business, neuroscience and more.
- **Best Practice** - Provides a second opinion in an instant, without the need for checking multiple resources. Its unique patient-focused approach represents a major new advancement in information delivery at the point of care.
- **Foundation Center Online** – A single-user database, FDO provides current, comprehensive information on U.S. grantmakers and their grants, including fields of interest, geographic focus, types of support, financial data, and application information. - **ClinicalKey Trial (beta)**

- **Access Full-Text of Baystate journal subscriptions in PubMed:** When displaying PubMed search results, note the drop-down menu next to the "Display Settings" option on the left hand side of the page. Change the "format" radio button from "summary" to "abstract" to see abstracts for search results as well as "Baystate Library Holdings" icons that connect to the full text of journal articles.
